

### The process of Consultation as set by the council






## **School Parent Consultations**

# Parent Consultations - what meaningful consultation should look like

## School Parent Consultations - Legal Requirements as set by DfE

13. <u>Schools</u> must **consult** parents in **developing** and **reviewing** their policy. And that it **meets the needs** of pupils and parents and **reflects the community they serve.** 

24. <u>Schools</u> should **ensure** that when they **consult parents** they should **provide examples of the resources** they plan to use. 41. All <u>schools</u> should work closely with parents when **planning** and **delivering** these subjects. Schools should **ensure** that parents know **what** will be taught and **when...** 

34(3b) <u>School</u> has the duty under law for the education to be **appropriate** having regard to the **age and religious background of the pupils.** [CSWA 2017]



### Parent Consultations-What criteria should the school consultations meet ?

1. Schools must still be open to making changes

2. Provide sufficient information, easily accessible, interpretable and understandable.

3. Adequate time is given for parents to respond

4. 'Conscientious consideration' must be given to the consultation responses before a decision is made



### **Examples of some of your Concerns**

1. <u>Sexual orientation</u> - Yearly reference to it in the primary syllabus and secondary syllabus.

37. Schools should ensure that all of their teaching is **sensitive and age appropriate** in approach and content. At the point at which schools consider it appropriate to teach their pupils about LGBT, they should ensure that this <u>content is fully integrated</u> into their programmes of study for this area of the curriculum rather than delivered as <u>a standalone unit or</u> <u>lesson. Schools are free to determine</u> how they do this, and we expect all pupils to have been taught LGBT content <u>at a timely point</u> as part of this area of the Curriculum.



#### Guidance: Plan your relationships, sex and health curriculum-24/09/2020

All pupils should receive teaching on lesbian, gay, bisexual and transgender (LGBT) relationships <u>during their school years</u>. Secondary schools should include LGBT content in their teaching. Primary schools <u>are strongly encouraged</u>, and enabled, when teaching about different types of family, to include families with same sex parents.



### Guidance: Relationships Education (Primary)-9 July 2020 By the end of primary school:

'Marriage in England and Wales is available to both opposite sex and same sex couples. The Marriage (Same Sex Couples) Act 2013 extended marriage to same sex couples in England and Wales. The ceremony through which a couple get married may be civil or religious'



#### 2. Topics involving gender and biological sex

'You should not reinforce harmful stereotypes, for instance by suggesting that children might be a different gender based on their personality and interests or the clothes they prefer to wear.

#### 3. Sex Education - Right to withdraw in Primary

68. DfE statutory guidance -Primary schools that <u>choose to teach</u> sex education <u>MUST ALLOW</u> <u>parents a right to withdraw</u> their children.

Policy- whether it's taught, state the aspects taught, consult parents. Must state clearly exactly <u>what aspects</u> of sex education are covered <u>in</u> <u>what terms and years</u> is helpful to allow parents and carers to make this decision.

#### Sex Education - Right to request withdrawal in secondary

- Policy must state this right **clearly** and **who** to contact to request.
- When a request is received, schools **can** consider a meeting to discuss this. If <u>parents and carers **decline** an invitation</u> to a discussion, school must **still process** their request for withdrawal .
  - Unless there are exceptional circumstances, parents and carers' requests should be granted until 3 terms before the pupil turns 16.



#### 4. <u>Body Parts</u> -This is new to RSE. Not a statutory requirement. Safeguarding vs safeguarding. What do we mean?

5. <u>Unintended Consequences</u> - Discuss any specific worries with school.

#### DfE Statutory guide

- 23. Appropriate for the age and maturity of pupils
- Be factually accurate.
- When using **external agencies** must be **in line** with your school's legal duties regarding political impartiality.(eg PHSE Association, Jigsaw, Twinkl, Stonewall, Christopher Winter)

#### Guidance; Plan your relationships, sex and health curriculum-24/09/2020

#### **Biological sex/transgender-**

- Schools MUST NOT work with organisations who produce material which suggests that non-conformity to gender stereotypes should be seen as synonymous with having a different gender identity.
- Resources used in teaching about this area must be evidence-based.
- Ensure all **content, resources and external agencies** used are <u>impartial</u> and ensure <u>balanced presentation of opposing political views</u>
- <u>NOT under any circumstances</u> work with **external agencies** that <u>take or promote extreme</u> <u>positions</u> or <u>use materials</u> produced by such agencies.



## **Resources** You may choose to ask your school...

- Will school maintain an agreed list of vetted/consulted resources?
- Will the school let you know of **new providers** or when **external agencies** are invited into school?
- **How** will schools **monitor** teachers' choice of material?
- Who prepares the lesson plans? Can you request to view them?
- How will the teachers be **trained**? What external organisations are providing training?
- Check resources against the **requirements /criteria** they should meet.

### **Group Discussions**

<u>Step 1</u> - Pick a topic from the syllabus to frame a relevant question. \*Remember to make it open-ended

<u>Step 2</u> - Ask them to explain how this topic will be taught in a way that is **in-line with your faith** or is **age-appropriate** to your child

Step 3 - Try to offer a viable and practical solution (delay/removal)



## **Conflict Resolution**

What to do if despite all your efforts, you feel your views are not given due attention?

- 1. Discussion with school.
- 2. School complaints procedure.
  - Keep a paper/email trail of all correspondence.
  - Identify your rights and which ones you believe are being disregarded.
  - Cc the board of school governors with your concerns.
  - Cc Parents United, Cc panel of FORMO so we know you have raised it.
- 3. Contact Parents United who will be able to advise you further.
- 4. Contact Councillors/Mps who are there to serve you.
- 5. Attend Education Scrutiny meetings.
